SECURITY: Uniformed Police Officer/s will be on hand, in addition to a staff of (2) provided by Production Sud. All Exhibitors are asked to use their own discretion in providing personal safety as they would in any other urban environment. (Watch your valuables, & money, etc. etc.)

ATTENTION DEALERS: Do not leave any food or discarded garbage, or items not sold this includes packing paper, boxes of any kind, please respect the city locations. As you would so in your own town, or city, or your own backyard violators will be banned from all shows promptly! And also pay the city fines for garbage without fail.

Directions from the South:

Take I-95 North to 836 East. Mac Arthur Causeway to Alton Road North.
Travel on Alton Road to 17th St. make a right, on Michigan Ave. You've arrived. There is a large parking lot between Lenox & Michigan Aves.

The City of Miami Beach Directive

Guidelines for the Lincoln Road Antique Market

Adherence to the size dimensions of the rented space.

The Antique Market designed rented spaces to accommodate EMS Vehicles and the pedestrian traffic flow along Lincoln Road Mall. Please do not block any of these walkways. Dealers that share spaces must be realistic about how much they bring, and not spread out beyond the booth spaces rented.

Tablecloths are mandatory. They must be floor length to the ground, black or dark colors only. With no boxes or storage visibly showing. Attractive set-ups are Important.

While Production Sud provides the tented space, we strongly urge vendors to purchase canopy weights. <https://ebay.us/m/3iq1vZ>

No new and or mass-produced Merchandise.

This includes FAKE DESIGNER REPRODUCTIONS, Sunglasses, Designer Bags, Jewelry, and or new Clothing.

All Dealers must begin to breakdown no later than 4:30 pm, to be off the Road by 6:00 PM. The City will issue fines for time violations.

Please be respectful, do not leave behind any items, and properly discard any and all garbage, including packing, boxes, paper, plastics, and food.

Any violation of the rules will result in moving of your space or removal from the Market.
